中国合格评定国家认可委员会是根据《中华人民共和国认证认可条例》的规定，由国家认证认可监督管理委员会（CNCA）批准设立并确定的国家认可机构，统一负责对认证机构、实验室和检验机构等相关机构的认可工作。英文名称为：China National Accreditation Service for Conformity Assessment（英文缩写为：CNAS）。



CNAS秘书处设在中国合格评定国家认可中心，是CNAS的法律实体，承担CNAS开展认可活动所引发的法律责任。

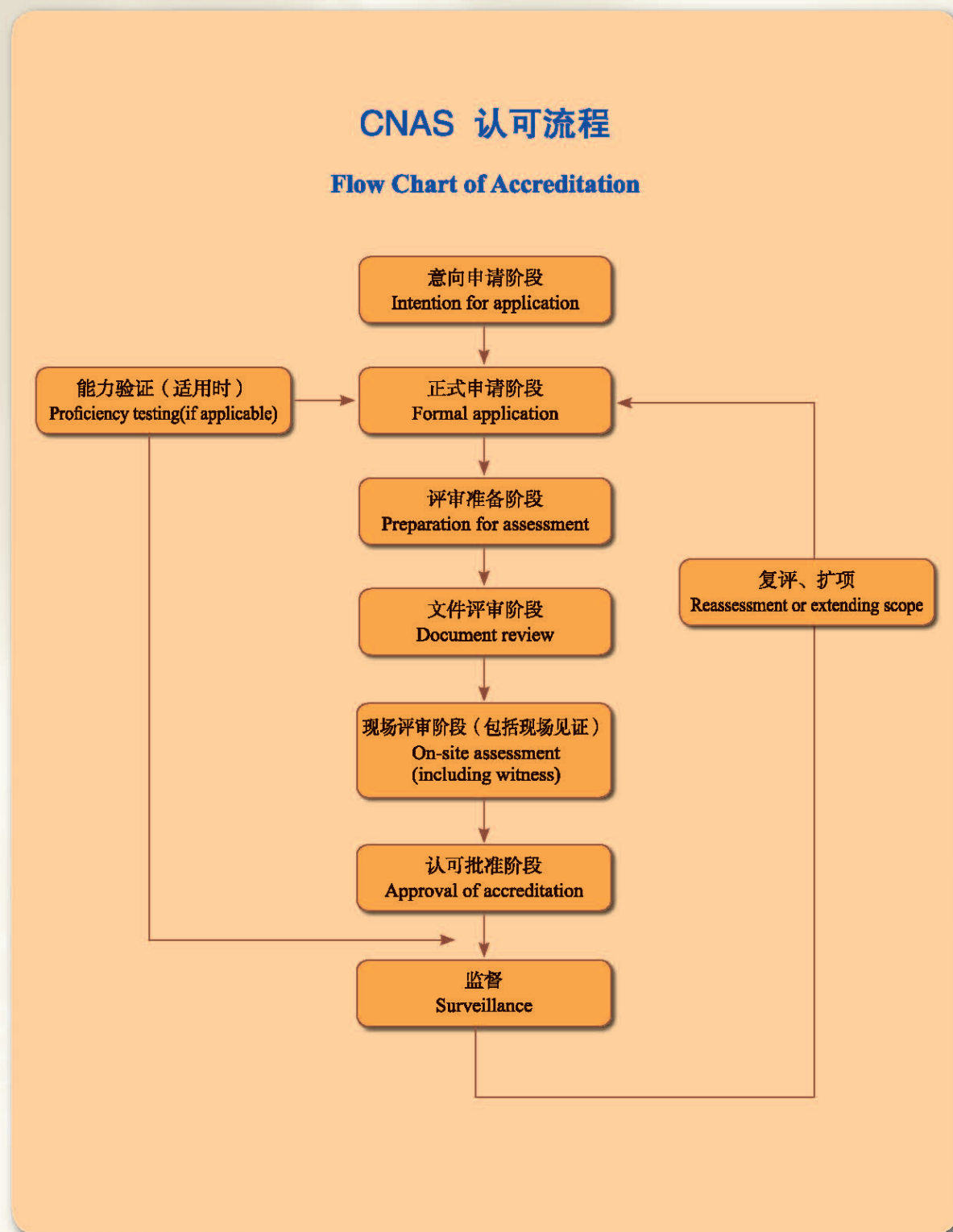
截至2019年12月底，CNAS认可各类认证机构、实验室及检验机构三大门类共计十五个领域的11409家机构，其中，累计认可各类认证机构188家；累计认可实验室10615家，其中检测实验室8722家、校准实验室1291家、医学实验室407家、生物安全实验室89家、标准物质生产者20家、能力验证提供者79家、实验动物机构6家、科研实验室1家；累计认可检验机构606家。

China National Accreditation Service for Conformity Assessment (hereinafter referred to as CNAS) is the national accreditation body of China unitarily responsible for the accreditation of certification bodies, laboratories, inspection bodies and relevant bodies, which is established under the approval of the Certification and Accreditation Administration of the People's Republic of China (CNCA) and authorized by CNCA in accordance with the Regulations of the People's Republic of China on Certification and Accreditation.

CNAS Secretariat is the permanent executive organ of CNAS with its office located inside China National Accreditation Institute of Conformity Assessment (CNAI). As the registered legal entity of CNAS, CNAI assumes legal liabilities arising from the accreditation activities of CNAS.

By the end of December 2019, CNAS accredited certification bodies, laboratories and inspection bodies were 11409 in total, which are in 3 major categories and 15 fields. Including, CNAS has totally accredited 188 certification bodies in various fields. CNAS has totally accredited 10615 laboratories and related bodies, including 8722 testing laboratories, 1291 calibration laboratories, 407 medical laboratories, 89 bio-safety laboratories, 20 reference material producers, 79 proficiency testing providers, 6 laboratories animal institutions and 1 research laboratories. CNAS has totally accredited 606 inspection bodies.

任务职能

- 1.按照我国有关法律法规、国际和国家标准、规范等，建立并运行合格评定机构国家认可体系，制定并发布认可工作的规则、准则、指南等规范性文件；

- 8.承担政府有关部门委托的工作；
- 9.开展与认可相关的其他活动。

Tasks of CNAS

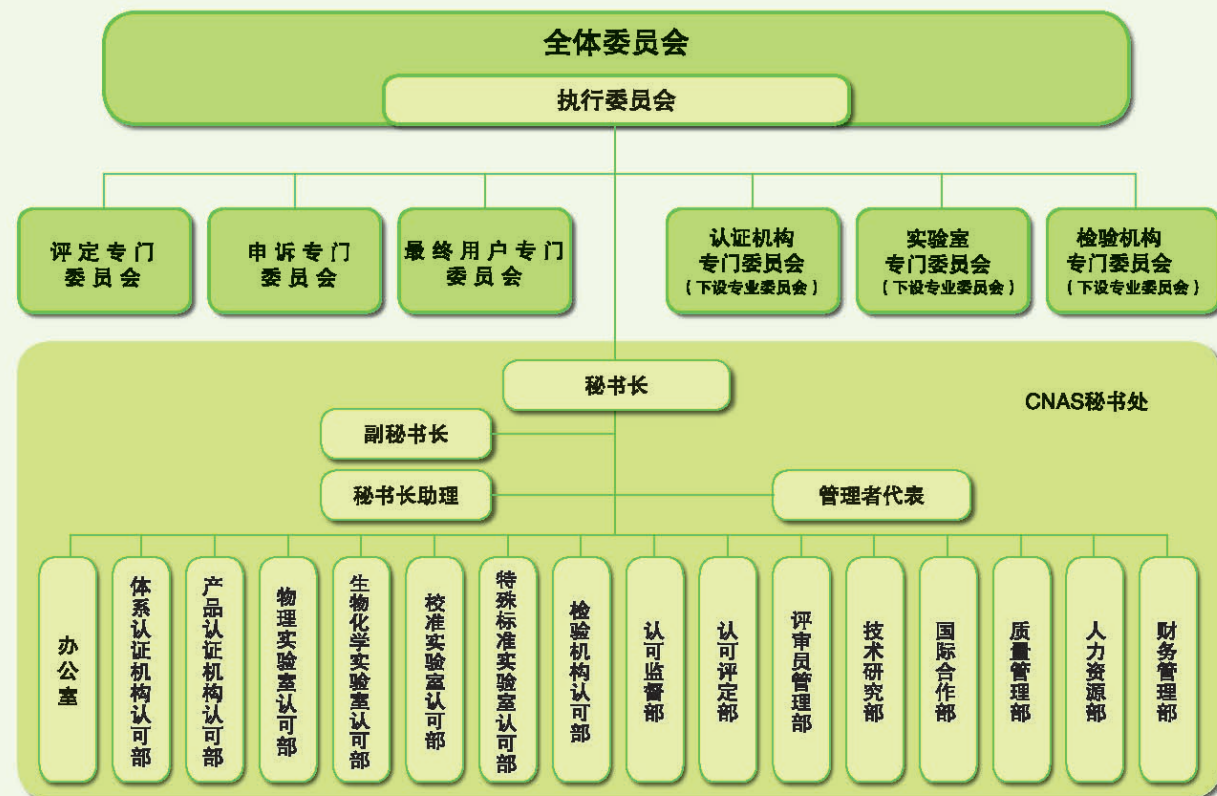
- a) To establish and operate the national accreditation system for conformity assessment bodies, and to develop and issue the normative documents e.g. rules, criteria and guidance etc. for accreditation, in accordance with relevant national laws and regulations as well as international and national standards and specifications;
- b) To assess the competence of local or foreign applicant conformity assessment bodies, make accreditation decisions, and conduct accreditation-related surveillance and management on accredited conformity assessment bodies;
- c) To assume the responsibility for directing and regulating the uses of CNAS logo and accreditation symbols;
- d) To organize personnel training related to accreditation, and to qualify, recruit and manage the accreditation personnel;
- e) To offer relevant technical services to conformity assessment bodies, and to provide society with publicly available information about accredited conformity assessment bodies;
- f) To participate in international activities related to conformity assessment and its accreditation, and to sign bilateral or multi-lateral accreditation cooperation agreements with relevant accreditation bodies, related bodies or international organizations;
- g) To deal with appeals and complaints related to accreditation;
- h) To undertake tasks assigned by relevant government departments;
- i) To carry out other activities related to accreditation.

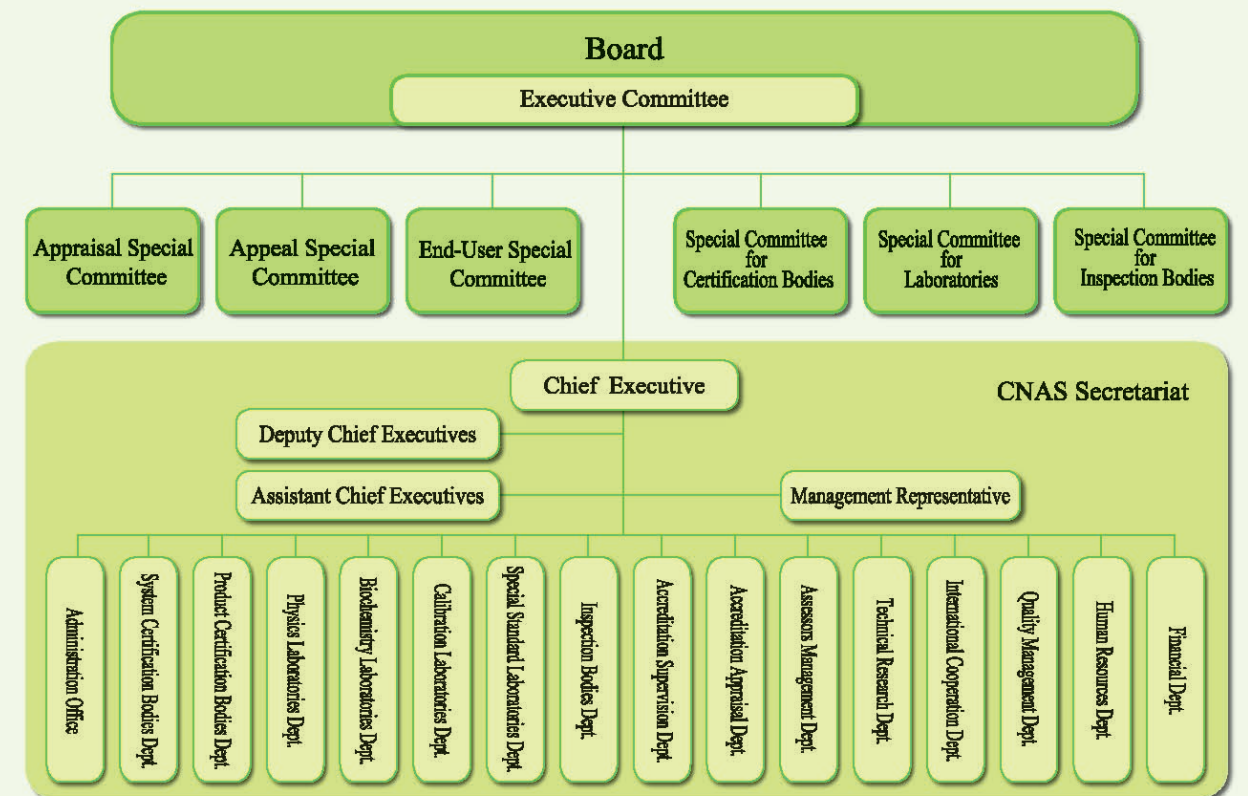
CNAS组织结构图
